

5. During the period of your probation or any extension thereof, you should show aptitude for the work, acquire knowledge of rules and regulations of Bank's business, policies and procedures etc. and discharge the allotted duties and responsibilities satisfactorily. You should also submit monthly reports (about area of work learnt) to Head Office through Branch Head.
6. If, at the end of probationary period, you are found suitable for the post, you will be confirmed in the services of the Bank. Otherwise, your services will be dispensed with. The Bank shall not be responsible or liable in any manner for consequences of such termination of your services.
